- The Loss of Income benefit payable is limited, subject to the Trustee's discretion, to the lesser of the selected amount or 85% of **net weekly earnings** (excluding any remuneration from participation in cricket).
- Loss of income payments made to the claimant are made net of tax.
- Loss of Income benefits are payable only if the player is in permanent or regular casual employment at the time of receiving the injury – also subject to the Trustee's discretion.
- The elimination period for loss of income benefits is 14 days, unless your sick leave balance exceeds this, in which case your sick leave balance becomes your elimination period.
- Players are also covered whilst training, therefore it is important to submit this form and payment early to ensure pre-season training sessions are covered.
